Course Prerequisites:

Admittance to the MSAT professional program.

Course Description:

The purpose of this course is to review and evaluate clinical competency required by the NAU AT Program. Additionally, students will submit weekly reflections, semester evaluations (3), and complete a practical evaluation.

Typhon: Allied Health Student Tracking System:

Students and Preceptors will track core competencies using the Typhon system. (https://www.typhongroup.net/ahst/index.asp?facility=9378)

Course Structure/Approach:

A brief review and overview lecture on a specified topic will be given weekly. Clinical Preceptors will help students practice clinical skills, as well as evaluate and document student competence in the application of clinical skills at the students' assigned clinical site(s). Practical skills may be assessed in class; however, the CP is responsible for evaluating the level of proficiency.

<u>Textbooks/Materials (R=required, O=optional)</u>: Supplemental readings from scholarly journals may be required for students. The purpose of the scholarly journal readings is to expand on current knowledge obtained during the undergraduate experience, and to apply that knowledge at the clinical site when working with injured athletes.

Student Learning Outcomes (SLO):

Upon successful completion of this course, the student will:

- 1. Demonstrate competence in the skills associated with this course (501A-501H; CAATE Standards 61, 65, 66, 78, 80, 85, 86, 90 See Below)
- 2. Exemplify the qualities associated with being a 1st semester MSAT student (professionalism, communication, work ethic, engagement/participation)
- 3. Understand the roles and responsibilities of an athletic training student
- 4. Develop and attain student-specific goals related to being a first semester MSAT Student.
- 5. Demonstrate reflective journaling based on observations and learning that takes place during Interprofessional Practice Clinical Rotations.
- 6. Understand the roles and responsibilities of medical and allied healthcare providers, other than athletic trainers.

Assessment of Student Learning Outcomes (SLO):

- 1. All competencies evaluated as "Competent" ("C" in Typhon) by Clinical Preceptor. (SLO 1)
- 2. Complete a practical exam with a score of 70% or greater. (SLO 1)
- 3. Preceptor input and evaluation of AT student using Pre, Mid, and End-Semester evaluations in Typhonn. Evaluations indicate that the student demonstrates qualities associated with being a 1st semester MSAT student (professionalism, communication, work ethic, engagement/participation). (SLO 2, 3)
- 4. Clinical Preceptor evaluations of AT student (Pre, Mid, and End-Semester evaluations) indicate formative (pre & mid semester evaluations) and summative (end-semester evaluation) progress towards specific goals. (SLO 4)
- 5. Student reflections and patient encounters of weekly clinical experiences. (SLO 2, 3)
- 6. Successful completion of reflective journals for each week of the semester (14 total). Entries are meant to be reflective in nature to stimulate critical thinking concerning the integration of didactic skills with clinical practice. Students are not to submit a summary of what they did or observed during the clinical rotation, but rather a reflection of what they did and observed. (SLO 5 & 6)
- 7. Completion of 2 interprofessional practice clinical site rotations and evaluations of each site (SLO 2 & 6)*
 - *This Assessment may be completed during the spring semester of the first year, depending on timing of the assigned rotation.

Course Evaluation:

This course is graded **PASS/FAIL**. Each item in each area (1-5 below) must be attempted and must meet the criteria described for each item. In addition, students must attain a minimum final grade of at least 70% to pass this course.

- 1. **Core Competencies (SLO 1) 40 points:** Core Competencies (501A 501H) must be evaluated by the CP as Competent (C) in Typhon **prior to the 12/3/21 deadline**. Missing the due date for competencies will result in course failure. Anything less than "C" at the 12/3/21 deadline will result in a failing grade for the course.

Evaluations (SLO 2 & 3) 35 points - Students are expected to meet with their CP at 3 different times during the semester to discuss the pre, mid, and end-of-semester evaluations of the MSAT student by the CP. More than one failure to have the evaluations completed by the stated deadline (below) will result in a failing grade for the course. If you miss a deadline, the evaluation stills needs to be competed. Unsatisfactory scores on the end-semester evaluation may result in a failing grade for the course. In addition, students must complete an evaluation of their assigned clinical site, their assigned clinical preceptor, and an evaluation for each interprofessional practice clinical site. All evaluations are housed within the Typhon system.

- c. Pre-Semester Evaluation: Due no later than Friday, September 3 at 11:59 pm
- d. Mid-Semester Evaluation: Due no later than Friday, October 8 at 11:59 pm
- e. End-of-Semester Evaluation: Due no later than Friday, December 3 at 11:59 pm
- f. Student Evaluation of CP: Due no later than Friday, December 3 at 11:59 pm
- g. Student Evaluation of Clinical Site: Due no later than Friday, December 3 at 11:59 pm
 - i. Traditional Setting
 - ii. Orthopedic Setting (if assigned this semester)
 - iii. Rehabilitation Setting (if assigned this semester)
- 2. **Weekly Reflective Journals (SLO 2 and 3) 42 points:** Reflective journal entries are due through BbLearn every Sunday by 11:59 pm. The journals are to be reflective of the week's experiences to stimulate critical thinking processes concerning the integration of didactic skills with clinical practice.
 - a. The reflective journal may be a place for you to reflect on issues with CPs and clinical sites, but please also report all potential issues with your CP and/or clinical site. If the issue is not resolved after speaking with your CP, please contact your assigned clinical coordinator.
 - b. The information in your journal will not be shared directly with CPs and feedback will be given weekly by the course instructor.
 - c. Repeated failure to be reflective will not be accepted and will be recorded as a non-submission.
 - d. Journal deadlines may only be missed twice, but all journals must be competed. i. If a submission deadline is missed, the student has 48 hrs to submit the late journal (by Tuesday at 11:59 pm).
 - 1. More than 2 late journal submissions will result in a failing grade in the course
 - 2. You may only miss the 48 hr deadline once during the semester. More than one missed 48 hour deadline will result in a failing grade in the course.

4. Patient Encounters (SLO 2) 50 points – 50 patient encounters are required to be reported in the Typhon system. It is recommended that you submit at least 3-4 patient encounters per week. Students will select at least 4 patient encounters (two per IPP rotation) from their IPP rotations during the semester. Failure to complete all 50 patient encounters by December 3, 2021 will result in a failing grade for the course. Please pay close attention to the types of conditions and patient populations that you are required to evaluate/have exposure to during the MSAT program, and enter these conditions/exposures as patient encounters.

5. Practical Exam (SLO 1) 20 points -

Students are expected to complete a practical exam to demonstrate clinical skills (dates beginning after Thanksgiving break). The practical exam content is based on the competencies assigned to this clinical course. Students must pass this practical exam with a minimum score of 70% in order to earn 100% of total points (e.g., 70-100% = 20 points; 65-69.9% = 15 points; 60-64.9% = 10 points; 55-59.9% = 5 points; 55-59.9% = 5

6. IPE Event Attendance (**SLO 2 and 6**) **5 pts:** Students will attend a minimum of one IPE event that has been approved by the course instructor. Students must upload the IPE event completion certificate of attendance into the Typhon system no later than December 3, 2021. Failure to submit completion certificate will result in a failing grade for the course.

7. Attendance/Participation (SLO 2 & 3) 28 points — Students in the Athletic Training Program are expected to attend all class meetings. Students should arrive to class on time and be ready for instruction or laboratory activities at the stated time. If a student needs to miss a class for any reason, they must notify the professor prior to the scheduled class. If unable to notify the professor prior to class due to unforeseen circumstances, notify the professor as soon as possible. Students must notify the professor BEFORE class with the reason for absence AND get a response that confirms the absence as either "unexcused" or "excused." If students have an unexcused absence, they are not allowed at the clinical site that day/night. More than 2 unexcused absences at the clinical rotation or in the didactic portion of the class in the semester will result in a failing grade for this course.

Course Policies

No late work is accepted in this course.

Attendance / Participation – Class attendance is mandatory. Any absences should be cleared with the instructor prior to missing class and arrangements should be made to make up any work that will potentially be missed. In the case of an unforeseeable situation, contact must be made with the instructor within 24 hours. Each absence will be reviewed by the instructor to determine if it's excusable and if makeup assignments are going to be granted. Excused absences could be illness, university sponsored activities, and family or personal emergencies. It is noted that make up assignments for any portion of the course that is missed will be determined exclusively by the instructor and the individual student. These assignments shall assess similar objectives as the one missed but may come at a different class time or in a different format. Allowing a student to make up an assignment or course grade because of circumstances beyond their control will not warrant allowing other students the same make up. In the event you experience an unexcused absence, a 2% deduction from your final course percentage will occur. Each additional unexcused absence will result in a 5% deduction from your final percentage.

Attire – Please wear closed-toe shoes for class sessions held in the donor lab and athletic training lab. Long pants are required in the donor lab. Also, appropriate learning cannot take place in the classroom lab if students are not dressed appropriately. Students must have a t-shirt and shorts available for each class. Students who are not dressed appropriately for class or lab sessions will be asked to leave class. This is paramount especially as we have limited in-person time together.

Technology

Cell phones may not be used during class other than for purposes of accessing related apps. Laptops may only be used in class for LEARNING purposes, such as note taking and online research related to AT 520 and the day's lesson. Out of respect for your peers and Dr. Hostetter please make sure that all cell phones are <u>turned</u> off and put away before class begins.
