Mode of Instruction: Online

Course Description:

The purpose of this course is for students to gain competence with clinical and professional skills through clinical education experiences. While in the course, students will review and be assessed on their ability to perform specific core competencies required by the MS-AT program and our professional accrediting body, the CAATE.

Student Learning Outcomes:

Upon successful completion of AT 504, the graduate student will be able to:

- 1. demonstrate competency in the skills associated with this course (504A-504K)
- 2. demonstrate comprehension of athletic training domain content (*quizzes and BOC Self-Assessment Exam*)
- 3. illustrate the qualities associated with being a 3rd semester MS-AT student (professionalism, communication, work ethic, engagement/participation) (*semester evaluations by Clinical Preceptor [CP] and reflective journals*)
- 4. identify the roles and responsibilities of an athletic training student (*clinical rotation and reflective journals*)
- 5. develop and attain student-specific goals related to being a 3rd semester MS-AT student (*semester evaluations by CP and reflective journals*)

Required Textbooks:

Course Structure:

It is the responsibility of the student to initiate the review and discussion of the course proficiency evaluations. Any questions or concerns regarding the Clinical Site or Clinical Preceptor at that site need to be directed to the appropriate Clinical Coordinator.

Course Evaluation:

This course is graded **PASS/FAIL**. Each item in the specific areas (1-6 below) must be attempted and meet the criteria described. In addition, students must attain an **overall minimum of 70% to pass this course**.

- 1. **Competencies (SLO 1) 34%** Suggested completion of competencies are presented in the course schedule. The MS-AT student is responsible for planning review and discussion of the competencies with their CP. By the end of the semester, **12/3/21 by 11:59 pm**, all competencies need to be evaluated as "Competent" in Typhon by your CP. If all competencies are not marked "Competent", as of 12/3/21 at 11:59 pm, you will not pass this clinical course.
- 2. Quizzes (SLO 2) 39% Thirteen timed quizzes. The first 8 quizzes are approximately 50 random questions that are pulled from the questions in your Van Ost text; you will have 60 minutes per quiz on Bb Learn. You may take each quiz (the first 8) up to 3 times. Quizzes 9-13 will involve practice exams from the SLACK website that is associated with your Van Ost textbook (https://www.healio.com/books/slackexams/atexam6). You may only take quizzes 9-13 one time. After you have completed the assigned SLACK website practice quizzes (quizzes 9-13), please screenshot your computer screen, showing completion of the exam, and upload that screenshot in Bb Learn under the Quizzes Tab. To ensure you are making an authentic effort on each quiz in honest preparation for your BOC Exam, the following parameters are set on the quizzes. It is strongly encouraged that you prepare prior to taking your first attempt, and do not use the book or other sources when taking the exam.
 - You must complete, at minimum, one quiz/exam attempt prior to the posted due date (Sundays at 11:59 pm). You may miss one quiz deadline. If you miss one quiz deadline, you will still have to complete the quiz you missed within 48 hours of the missed deadline. Failure to complete the missed quiz within 48 hours will result in a failing grade for the course. If you miss two quiz deadlines, you will fail this course.

- 3. BOC Self-Assessment Exam (SLO 2) 6% You are required to complete at MINIMUM 1 practice BOC Self-Assessment Exam provided to future AT candidates. They are intended to assess your competence and provide guidance on areas needing additional review to enhance your chance of first time BOC Exam Success. Complete one "Test Mode" Self-Assessment Exam (see link on page 1) independently by 12/3/21. Submit a screen shot of the exam results in Bb Learn. Late submission will not be accepted and will result in a grade of 'Incomplete' (I) for this course. Furthermore, to ensure your progressing toward BOC success, a score of 70% (averaged across all the test domains) must be achieved on the independent Self-Assessment Exam to pass this class. If you receive less than 70% you will receive an 'Incomplete' (I) for the course and will need to postpone taking the NATA-BOC examination until June (or first date available after the 2022 NAU spring commencement). It is encouraged that you take your exam early enough to allow for additional attempts as needed, potentially avoiding an 'I', delayed BOC exam dates or graduation. The incomplete (I) will be removed once you receive a score of 70% or greater on a retake during the Spring semester. Remember, the purpose of this exam is to provide an objective measure of your strengths and weaknesses in the 5 AT Domains and allow you to strengthen identified weaknesses prior to the actual BOC exam.
- 4. **Preceptor Evaluations (SLO 3-5) 6% -** Pre-, Mid-, and End-of-Semester Evaluations by the assigned CP. These evaluations are housed in the Typhon system, and will be completed by your clinical preceptor prior to the scheduled due dates. Students are expected to meet with their CP at three different times during the semester to discuss these evaluations.
 - Three CP evaluations of the MS-AT student are required to be submitted by the due dates below. These evaluations are integral to your reflective learning and are absolutely required, even if submitted late which will be required if you miss the due date. However, if you miss more than one due date, you will receive a failing grade for the course. Again, pay attention to details and plan ahead.
 - In addition, unsatisfactory scores on the end-of-semester evaluation may result in a failing grade for this course. If problems arise at your clinical site, address them early and do not wait till the end of or after the semester.
 - Pre-semester evaluation August 29th, 2021 by 11:59pm
 - Mid-semester evaluation October 10th, 2021 by 11:59pm
 - End of semester evaluations (CP of MS-AT student, MS-AT student of CP, and MS-AT student of clinical site) December 3rd, 2021 by 11:59pm
- 5. **Reflective Journals (SLO 3-5) 10% -** Journal entries are due through Bb Learn on specified Sundays by 11:59pm. The journals are to be reflective of the week's experiences to stimulate critical thinking processes concerning the integration of didactic skills with clinical practice.
 - The reflective journal may be a place for you to reflect on issues with CPs and clinical sites, but please also report all potential issues with your CP and/or clinical site. If the issue is not resolved after speaking with your CP, please contact your assigned clinical coordinator.
 - The information in your journal will not be shared directly with CPs and feedback will be given weekly by the course instructor.
 - Include daily hours along with a total for the week.
 - Repeated failure to be reflective will not be accepted and will be recorded as a non-submission.
 - Journal deadlines may only be missed once, but all journals must be competed.
 - o If a submission deadline is missed, the student has 48 hours to submit the late journal (by Tuesday at 11:59 pm).
 - More than 1 late journal submissions will result in a failing grade in the course.

- You may only miss the 48-hour deadline once during the semester. More than one missed 48-hour deadline will result in a failing grade in the course.
- 6. **Patient Encounters: (SLO 4) 5% –** 70 patient encounters are required to be reported in the Typhon system. It is recommended that you submit at least 3-4 patient encounters per week. Failure to complete all 70 patient encounters by 12/3/21 will result in a failing grade for the course. Please pay close attention to the types of conditions and patient populations that you are required to evaluate/have exposure to during the MS-AT program, and enter these conditions/exposures as patient encounters.
