Be sure to clear your browser cache before attempting to upload your document and use Microsoft Edge using the InPrivate, private window options. You can also email the form to: Financial.Aid@nau.edu. Please allow up to 10 business days for processing.

IMPORTANT: Canceling disbursed loans may result in charges immediately due on your account. These charges may also accrue late fees. Past-due charges may also prevent enrollment in future terms.

Please note that if you choose to decline your full loan amounts for the fall semester, your entire loan for the year will be canceled. You will need to contact our office to have your loan re-awarded for the spring only. If you are declining the entire amount of a PLUS (Grad or Parent) loan, your entire loan amount for the year will be canceled. You will need to apply for a Spring only PLUS loan.
